

## Minutes of The Full Council Meeting held on Monday 8<sup>th</sup> June 2020 at 7.30 pm Conducted Online Via Zoom

- 5. Minutes of the meeting held on 4<sup>th</sup> May 2020 were agreed, and it was RESOLVED that the Chairman signed them as a true record
  - 5.1 Matters outstanding from these minutes (not listed as separate agenda items) Cllr Edwards enquired if the hardship fund had been used, Clerk confirmed it hadn't.
  - 5.2 Matters **outstanding from previous minutes** None
- **6. Open session for questions from the public**: Mr Heasman informed members that Speedwatch would be commencing on the 15<sup>th</sup> June, limited group due to vulnerable volunteers not being able to participate. He also raised his concerns with the new entrance to the small development off of Lower Green Road. The other member of the public wanted to know when the road was due to be reopened.
  - 7. Session for County and Borough Councillors on matters concerning the Parish Cllr McInroy thanked KCC Highways for the work carried out in Rusthall during the last few months. TW have had more pot holes repaired than any other district. Cllr Funnell reported that some bollards had been replaced and that part of the footpath along Rusthall Road had been resurfaced.
  - **8. Update on volunteers and those seeking help** Cllr Britcher reported that the RVA had received 33 requests for help, since March. The volunteers were still helping with shopping and telephoning some of the 33. There had been 29 food boxes. An article will be in the RF, from Cllr Britcher.

  - **10.** Guidance for the business owners/managers as well as signs and public notices It was agreed that the Clerk would ask all shop owners if they would like posters and stickers to aid in their opening.

11. Chair's Report – Cllr Edwards reported that the allotments had been challenging during the year, so far. He believed that the Clerk had obtained as much information as possible, from the Gov and NAS and kept the plot holders fully informed at every stage. Cllr Edwards and Cllr Smith had removed some overhanging branches by the large gate at SWR site.
